ANNOUNCEMENT Changes in the volume of Discount Treasury Bill series

Pursuant to the Act CXX of 2001 on the Capital Market and Government Decree No. 286/2001 (XII. 26.) on treasury bill and in accordance with the annual Central Budget Act of Hungary, furthermore on the basis of the relevant document titled as “Offering Circular on the Public Issuance of Discount Treasury Bills” being effective at the original issuance of the series (hereinafter: the “**Offering Circular**”) and of the applicable public offerings (hereinafter: the “**Public Offerings**”), the Hungarian State (hereinafter: the “**Issuer**”) has previously issued registered, dematerialized Discount Treasury Bills with face value of HUF 10,000 as detailed below.
