ANNOUNCEMENT Changes in the volume of Hungarian Government Bond series

Pursuant to the Act CXX of 2001 on the Capital Market and Government Decree No. 285/2001 (XII. 26.) on bonds and in accordance with the annual Central Budget Act of Hungary, furthermore on the basis of the relevant document titled as “Offering Circular on the Public Issuance of Hungarian Government Bonds” being effective at the original issuance of each series (hereinafter: the “**Offering Circular**”) and of the applicable public offerings (hereinafter: the “**Public Offerings**”), the Hungarian State (hereinafter: the “**Issuer**”) has previously issued registered, dematerialized Hungarian Government Bonds with face value of HUF 10.000 as detailed below.
